**STATUT UNIVERSITI PERTANIAN MALAYSIA (PEMBAHAGIAN
UNIVERSITI KEPADA FAKULTI, YAYASAN DAN PUSAT)
(PINDAAN) 1983**

PADA menjalankan kuasa-kuasa yang diberi oleh seksyen 26 Perlembagaan Universiti Pertanian Malaysia, Canselor Universiti Pertanian Malaysia membuat, mengikut peruntukan-peruntukan seksyen tersebut, statut yang berikut:

1. Statut ini bolehlah dinamakan Statut Universiti Pertanian Malaysia (Pembahagian Universiti kepada Fakulti, Yayasan dan Pusat) (Pindaan) 1983 dan hendaklah disifatkan telah mula berkuatkuasa pada 1hb Mac 1982.

2. Perenggan 3 Statut Universiti Pertanian Malaysia (Pembahagian Universiti kepada Fakulti, Yayasan dan Pusat) 1978 adalah dipinda dengan—

(a) menggantikan perkataan “Perkhidmatan” dalam sub-perenggan (1) (v) dengan perkataan “Pengajian”;

- (b) memotong perkataan "dan" yang terdapat selepas sahaja perkataan "Pendidikan Lanjutan" dalam subperenggan (1) (viii);
- (c) menggantikan noktah yang terdapat selepas sahaja perkataan "Sains Samudra" dalam subperenggan (1) (ix) dengan koma bernoktah;
- (d) menambah dua subperenggan baru (1) (x) dan (1) (xi) seperti berikut:
 - "(x) Fakulti Sains dan Teknologi Makanan; dan
 - (xi) mana-mana Fakulti, Yayasan atau Pusat lain yang ditubuhkan dari semasa ke semasa melalui Statut.".

UNIVERSITI PERTANIAN MALAYSIA (DIVISION OF THE UNIVERSITY INTO FACULTIES, INSTITUTIONS AND CENTRES) (AMENDMENT) STATUTE 1983

IN exercise of the powers conferred by section 26 of the Constitution of the University Agriculture Malaysia, the Chancellor of the Universiti Pertanian Malaysia makes, in accordance with the provisions of the said section, the following statute:

Citation and commencement.

1. This Statute may be cited as the Universiti Pertanian Malaysia (Division of the University into Faculties, Institutions and Centres) (Amendment) Statute 1983 and shall be deemed to have come into force on the 1st March 1982.

2. Paragraph 3 of the Universiti Pertanian Malaysia (Division of the University into Faculties, Institutions and Centres) Statute 1978 is amended by—

- (a) substituting for the word "Services" appearing in subparagraph (1) (v) the word "Studies";
- (b) deleting the word "and" appearing immediately after the words "Continuing Education" in subparagraph (1) (viii);
- (c) substituting a semicolon for the full stop appearing immediately after the words "Marine Science" in subparagraph (1) (ix); and

(d) adding two new subparagraphs (1) (x) and (1) (xi) as follows:

"(x) the Faculty of Food Science and Technology; and
(xi) such other Faculties, Institutions or Centres as may from time to time be established by Statute.".
