

- (e) recommend the appointments of Visiting Professors for the Council's consent;
- (f) appoint assessors and examiners external and internal;
- (g) issue directions to examiners or Examination Board;
- (h) confirm the results of examinations of the University and award degrees, diplomas, certificates and other honours in accordance with Statute, Act and Regulations;
- (i) award fellowships, scholarships, prizes or medals in accordance with the conditions prescribed in the Act or Regulations concerning them;
- (j) make recommendations to Council in matters concerning the creation, change, replacement or substitution of posts of instructors and also matters concerning the qualifications of academic officers;
- (k) issue general directions concerning instruction and research in the Faculty, Institution, and Centre;
- (l) control the use of buildings and University facilities for the purpose of carrying out instruction and research;
- (m) issue general directions concerning library, museum, cultural halls and other instruction and research facilities projects;
- (n) make recommendations to Council concerning matters which are not specifically assigned to any authority.

Power to delegate.

6. Subject to section 51 of the Constitution of the University, the Senate may delegate any power or function which has been given to it by the Constitution, Statute, Act or Regulations to its members or a committee which consists of its members.

IN exercise of the powers conferred by section 26 of the Constitution of University Pertanian Malaysia, the Chancellor of University Pertanian Malaysia in accordance with the provisions of the said section 26 makes the following Statute:

Citation.

1. This Statute may be cited as the **University Pertanian Malaysia (Determination of Degrees and Diplomas) Statute 1977.**

**AKTA UNIVERSITI PERTANIAN MALAYSIA (ACARA KONVOKESYEN) 1977**

PADA menjalankan kuasa-kuasa yang diberi oleh seksyen 28 Perlembagaan Universiti Pertanian Malaysia, Majlis Universiti Pertanian Malaysia selepas berunding dengan Canselor mengikut kehendak seksyen 44 Perlembagaan Universiti Pertanian Malaysia membuat Akta yang berikut:

1. Akta ini bolehlah dinamakan **Akta Universiti Pertanian Malaysia (Acara Konvokesyen) 1977.**

*Nama.*

2. (1) Dalam Akta ini, melainkan jika kandungan ayatnya menghendaki makna yang lain—

*Tafsiran.*

“Fakulti” adalah termasuk sesuatu Yayasan atau Pusat yang bukan sebahagian daripada sesuatu Fakulti.

(2) Akta ini hendaklah dipakai dengan apa-apa ubahsuaian yang perlu apabila sesuatu Konvokesyen dipengerusikan oleh seorang Pro Canselor atau oleh Naib Canselor.

3. Suatu Konvokesyen bagi pengurniaan ijazah-ijazah dan diploma-diploma hendaklah diadakan pada tiap-tiap tahun, atau seberapa kerap yang diarahkan oleh Canselor, pada tarikh dan tempat yang diluluskan oleh Canselor.

*Konvokesyen.*

4. Ijazah-ijazah dan diploma-diploma Universiti hendaklah biasanya dikurniakan hanya kepada orang-orang yang hadir disesuatu Konvokesyen dengan syarat bahawa Senat boleh, dalam keadaan luar biasa, memutuskan supaya sesuatu ijazah atau diploma dikurniakan tanpa hadir.

*Pengurniaan ijazah dan diploma kepada orang yang hadir.*

5. (1) Sesuatu Konvokesyen hendaklah dipengerusikan oleh Canselor atau, jika Canselor tidak hadir, oleh seorang Pro Canselor yang diberi kuasa bagi maksud ini oleh Canselor.

*Pengerusi Konvokesyen.*

(2) Jika Canselor dan Pro Canselor yang diberi kuasa bagi maksud ini oleh Canselor tidak hadir pada sesuatu Konvokesyen, Konvokesyen itu hendaklah dipengerusikan oleh Naib Canselor.
