DASAR UNIVERSITI PUTRA MALAYSIA
(VAKSINASI COVID-19) 2021

Pegawai dan pelajar Universiti adalah bertanggungjawab untuk mendapatkan dos imunisasi COVID-19 yang lengkap sebagaimana yang telah ditetapkan oleh Kerajaan dan Universiti untuk memastikan persekitaran tempat kerja termasuk persekitaran pengajaran dan pembelajaran yang selamat kepada warga UPM, serta penyampaian perkhidmatan serta produktiviti perkhidmatan di Universiti berada pada tahap optimum.

Orang awam yang hendaklah berurusan dengan Universiti secara fizikal hendaklah mempunyai dos imunisasi COVID-19 yang lengkap bagi memelihara keselamatan dan kesihatan pegawai dan pelajar Universiti.


Walau apapun yang dinyatakan dalam Perenggan 1 dan 2 Dasar ini, pegawai dan pelajar Universiti serta orang awam yang tidak lengkap dos imunisasi COVID-19 dan ingin berurusan secara fizikal dengan Universiti hendaklah mematuhi Dasar COVID-19 Kebangsaan yang dikemas kini dari semasa ke semasa oleh Kementerian Kesihatan Malaysia.

Perenggan 1 dan 2 Dasar ini berkuat kuasa mulai 1 November 2021 dan perenggan 3 Dasar ini berkuat kuasa mulai 10 Februari 2022.

**UNIVERSITI PUTRA MALAYSIA POLICY
(COVID-19 VACCINATION) 2021**

The staff and students of the University are responsible for obtaining the complete dose of COVID-19 immunization as prescribed by the Government and the University to ensure the safety of the workplace environment including a safe teaching and learning environment for UPM staff and students, and the service delivery and productivity of the University are at the optimum level.

Any member of the public who wishes to do any business dealing with the University physically shall have the completed dose of COVID-19 immunization to ensure the safety and health of the staff and students of the University.


Notwithstanding anything in paragraph 1 and 2 of this Policy, staff and students of the University, as well as public, who have not completed immunization dose of COVID-19 and are desirous to do any business dealing with the University physically shall comply with the National COVID-19 Policy as may be updated from time to time by the Ministry of Health Malaysia.

Paragraph 1 and 2 of this Policy shall come into force on 1st November 2021 and paragraph 3 of this Policy shall come into force on 10th February 2022.
